General Liability

Production Central Stages LLC rents its facilities, including limited equipment, to its clients with the understanding that in no event shall Production Central Stages, LLC or Production Central Stages, LLC Employees be held liable for direct, indirect, incidental, or consequential damage due to the use of this facilities or equipment used by its clients. I hereby waive and hold harmless Production Central Stages, LLC and Production Central Stages LLC Employees from any incidents or accidents which may occur to or by persons either renting or associated with the rental from Production Central Studios LLC and Equipment.

General Liability insurance is required and certificate naming "Production Central, Inc" as additional insurance shall be delivered (by e-mail, PDF, in person, fax or mail). Once the contract is signed, Production Central is relieved of all responsibility for unforeseen circumstances (i.e. fire, mechanical building breakdowns, accidents, ect.).

Rates & Fees

Studio 34th Street - \$2500/10hrs, includes power and trash.

Studio Overtime - \$375/hr

Greenscreen option + \$250

Studio #303 - \$2500/10hrs, includes power and trash.

Studio Overtime - \$375/hr

Greenscreen option + \$250

Studio #205 - \$2000/10hrs, includes power and trash.

Studio Overtime - \$300/hr

Greenscreen option + \$250

Crew Overtime after 10 hours is 1.5 times hourly rate.

Crew Overtime after 12 hours is 2 times hourly rate.

Overtime hours are billed in whole hours, based on availability, no exceptions.

After hours Freight Elevator use Fee (Before 8am, After 6pm) - \$50/hr

Trash Fee (required) - \$50

Construction Debris Removal - \$150

Electrical Fee (required) - \$150

\$400 Non-refundable deposit is required to book a date. Deposit is applied to the renters balance.

Payments made by credit card are subject to a 3% charge of the total balance. Full Payment of the balance is required at the end of the rental period.

Cancellations

24 hr notice – 100% of stage, crew and equipment rental
48 hour notice – 50% of stage, crew and equipment rental

Responsibilities

Renter will leave studio clean and neat just as they found it. All equipment returned to where it was found and turned off. Furniture put back in its place. If not renter will be charged a \$50 cleaning fee.

Renter also agrees that any equipment, furniture, fixtures, ect. that are mishandled, broken, ruined or stolen while they are using the studio will replace all items or pay for repair/replacement cost.

Absolutely NO SMOKING whatsoever.

Absolutely NO TAPE OR SCREWS OR NAILS ON THE FLOORS OR WALLS.

Items left after 7 days will be assumed abandoned and may be discarded.
